**OFFICIAL DECLARATION**

We, the undersigned Owners/Operators of the vessel(s) listed above, hereby irrevocably undertake and warrant to *[Company / Manager Name]* that the Vessel(s) shall at all times comply with applicable United States sanctions laws and regulations, including but not limited to those administered by the U.S. Department of the Treasury, Office of Foreign Assets Control (OFAC).

**1. IRAN – PROHIBITED / SANCTIONABLE CARGOES**

We confirm that the Vessel(s) shall not load, carry, transport, or otherwise be involved in any shipment originating from Iran involving the following cargoes (whether directly or indirectly):

(a) Energy & Petroleum Cargoes

- Crude oil
- Condensates
- Refined petroleum products (fuel oil, gasoil, LPG, LNG)
- Any petroleum or hydrocarbon derivatives

(b) Petrochemical Products

- Methanol, ammonia, urea
- Polymers and plastic feedstocks
- Any petrochemical products linked to Iranian origin

(c) Metals & Mineral Commodities

- Iron, steel, aluminum, copper
- Any raw or semi-finished metal products

(d) Military, Defense & Dual-Use Cargoes

- Weapons, ammunition, explosives
- Missile, drone (UAV), or aerospace components
- Nuclear-related materials or equipment
- Any dual-use goods capable of military or proliferation use

(e) Industrial & Strategic Goods

- Equipment, machinery, or materials supporting:
- Oil & gas sector
- Petrochemical sector
- Military or nuclear programs

**2. RUSSIA – PROHIBITED / SANCTIONABLE CARGOES**

We confirm that the Vessel(s) shall not load, carry, or transport cargoes of Russian origin in violation of U.S. sanctions, including:

(a) Energy Cargoes (Primary Restrictions)

- Crude oil
- Petroleum products (diesel, fuel oil, etc.)

- Liquefied natural gas (LNG)
- Coal and coal products

Particularly where:

- Price cap rules are breached, or
- Transactions involve sanctioned entities or vessels (OFAC<sup>(OBJ)</sup>)

(b) Metals & Natural Resources

- Aluminum, copper, nickel
- Iron and steel products
- Mining sector commodities

(c) Diamonds & Luxury Commodities

- Diamonds (including unsorted and jewelry forms)
- Certain high-value goods subject to import/export prohibitions

(d) Fish, Seafood & Selected Commodities

- Fish, seafood, and related preparations (as restricted under U.S. determinations) (OFAC<sup>(OBJ)</sup>)

(e) Military & Industrial Sector Cargoes

- Goods linked to Russia's military-industrial base
- Machinery, electronics, or components supporting defense or strategic industries

**3. GENERAL PROHIBITIONS (IRAN & RUSSIA)**

The Owners further undertake that:

- The Vessel(s) shall not engage in ship-to-ship (STS) transfers intended to conceal origin of sanctioned cargo
- The Vessel(s) shall not manipulate AIS or documentation to evade sanctions
- The Vessel(s) shall not call at sanctioned ports or deal with sanctioned entities, vessels, or cargo interests
- Full due diligence shall be conducted on:
  - Charterers
  - Cargo origin
  - Bills of lading
  - Counterparties

**4. HUMANITARIAN EXCEPTION**

This undertaking does not prohibit lawful transport of humanitarian cargo, including:

- Food
- Agricultural commodities
- Medicines and medical devices

Provided always that such shipments are:

- Fully compliant with applicable sanctions laws
- Not involving sanctioned entities, vessels, or financial channels

## 5. WARRANTY & INDEMNITY

The Owners warrant that:

- They shall remain fully compliant with all applicable sanctions regimes
- They shall indemnify and hold harmless the international ship registry of Togo from any consequences arising from breach of this undertaking
- Any breach shall be considered material and grounds for immediate Cancellation of vessels's registration .
